WHITE PINE SPECIFICATIONS - Effective 10 May 2024

GRADE	Minimum Diameter	LENGTHS (ft) Add 4"-6" trim	SPECIFICATIONS
1 Select	14"	10'-12'-14'-16' (8' Max 10% of load)	3 clear faces, not more than ½ inch knots on fourth face. 16' preferred when possible.
2 16' Sawlog	5"	16'	Max. knot size: 2" Black; 3" Red
3 Short Sawlog	5"	10'-12'-14'	Max. knot size: 2" Black; 3" Red.
4 Long Pallet	8"	10'-12'-14'-16'	Logs not meeting the above specifications. 16' length preferred when possible.
5 Short Pallet	8"	8'	No "pasture pine"

GENERAL SPECIFICATIONS:

Sweep	NO sweep on logs 5" to 7" diameter. Discounts for >1.5" of sweep per 8' length.
Maximum Diameter	48" maximum
Crotches	Logs with crotches will be scaled back to beginning of crotch.
Culls	Culled Logs not removed by supplier within 10 days become mill property.
Limbs	Limbs must be trimmed flush with log.
Metal	Any logs showing iron or iron stain will not accepted.
Rot	Up to 50% well centered rot is allowed, with a discount on scale <u>not</u> grade.
Seams	One straight seam acceptable with discount
Stain	None acceptable
Trim	Trim allowance is 4" minimum to 6" maximum.
Length	Logs over 17'0" and under 8'4" will be rejected.

NOTES:

- All logs scaled using the International 1/8" rule measured inside the bark.
- No log shall be accepted if log contains over 50% deduction.
- Logs cut April through September must be delivered to mill within 10 days.
- Suppliers must be set up by an Irving Woodlands LLC Log Buyer prior to delivery, including agreement to comply with the standard terms and conditions for Dixfield, ME.
- New loggers or truckers must provide to following data at the scale office: name, address, phone number, social security or federal ID number. Failure to do so will delay your log payment.
